## **TERMS OF BUSINESS**

### **Investment**

The cost of the training used to cover all you would need to set up in business including a full set of 12 colour analysis drapes, a full set of 12 swatch wallets, makeup and skincare basic kit, a full set of 122 testing drapes, and sundry other materials. This amounted to \$5215. Nowadays we spread the cost out a little to make it easier for you.

Therefore cost of the training for **2017 will be \$2500** (incl GST) and will cover the comprehensive Colour Training Manual, Client Colour Assessment Charts, Client Record Charts, and a personal colour analysis valued at \$300 along with your personal wallet of colour swatches. A non-refundable deposit of \$500 is due upon registration to reserve your place on the course, and the balance to be paid one month before the course commences.

- There will be a further investment of \$650 for the large multi-colour drapes used in analysis, payable by the end of the training.
- Wallets of colour swatches for clients are available for \$45 each and can be purchased as required.
- A full set of individual drapes currently needs to be purchased off-shore as required.
- A makeup and skincare basic kit is an optional extra, also as required.

### **Cancellation terms**

Refunds (apart from non-refundable deposits) will only be given where notice is received 21 days before the course commences. 50% of the refundable element will be given for cancellations received 15 - 30 days before the event. No refunds will be given for cancellations received 14 days or less before the event.

The above prices are guaranteed until 31 December 2017.

Training will be in small groups of no more than 4 people, to ensure you get lots of personal attention at the same time as benefiting from the group dynamics.

At the end of the course, students are expected to complete a series of four post course assignments to ensure they are confident and competent to work independently. After this time each student receives a beautiful Certificate of Attainment certifying ability to conduct business as an image consultant.

Students will be provided with on-going mentoring as required for a minimum of six months after they receive their certificate.
